No. 1294/1130/2018/42(2) State Govt. hereby award work order to National Education Foundation (NEF)-USA for Pilot Project for training of students as below -

- (i) To train 360 students (180 boys and 180 girls) as Pilot batch from various degrees, viz, Engineering, Arts, Commerce, Science and Management, commencing from June 2018.
- (ii) The skills module shall comprise minimum 90 hours of training (30 hours online and 60 hours classroom) and shall be covered in not more than 90 days for each batch.
- (iii) NEF shall be solely responsible for Training, Evaluation, Certification (SUNY certified with NSDC (Level 6 or above) & Department of Technical Education, Skill Development & Employment (DTESDE) co-branded.
- (iv) For women trainees, 100% of the cost shall be borne by NEF. For men trainees, 80% of the total cost shall be borne by NEF and 20% of the cost (i.e. Rs. 3,900+Taxes) shall be paid by the Department (DTESDE). The fee payable by DTESDE shall be paid as per NSQF guidelines - 30% of the amount at the of enrolment, 50% on the completion of the training programme and 20% on placement of 70% of the trained students as per MOU.
- (v) NEF shall ensure the placement of at least 70% of the trained students.
- (vi) NEF shall provide Faculty, Training of Trainers (ToT) Program, Training and Assessment.
- (vii) DTESDE shall provide the list of campuses where the training has to be conducted and shall provide the necessary classroom infrastructure for the same.

Other feature of the pilot project would be as given below :-

1. Evaluation & Award Certification

Prior to the commencement of the program, all the registered students will have to undergo *Aptitude Test* & writing Skills to know their attributes and skills. At completion of every 10 hours student will undergo periodical assessment thru Paper-Pencil or Online. After completion of 90 hours of session; final assessment will be conducted by State University of New York.

Certificate of Completion will be awarded by NEF-SUNY to those students who secure 70% aggregate in the entire 9+1 assessment & final evaluation test, which will be jointly certified by NSDC.

2. Coordinator

Shri Chandra Mohan Thakur, Chief Executive officer, M.P. State Skill Development & Employment Generation Board will be coordinator from DTESDE & will be one point contact for the project execution.

3. Attendance

A strict attendance of 80 % is a must and there will be no deviation in this regard. Representative from the respective institution shall be one point of contact during the program under the intimation to DTESDE.

4. Course Duration

The course duration is 2 months and time table shall be finalized in consultation with concerned institutions, training program will run in their respective colleges in the classroom which can accommodate min 60 students with WiFi facility.

5. Expenditure

Expenditure for this pilot project will be met from Mukhyamantri Koushal Sanwardhan & Koushalya Yojana

6. Payment & Other Conditions

Payment and other terms & conditions shall be as per MOU signed between Deptt. of Technical Education, Skill Development & Employment, Govt. of M.P. (DTESDE) & National Education Foundation (NEF) on 09.05.2018 (copy enclosed). The copies of invoice (two) need to be submitted to MPSSD&EGB. The Board will make payment as per terms & conditions mentioned in MOU.

Memorandum of Understanding

This Memorandum of Understanding ("MOU") is entered into on this 9th day of May, 2018 ("Execution Date") by and between:

Department of Technical Education, Skill Development and Employment, Government of Madhya Pradesh (DTESDE) a department of the Government of Madhya Pradesh having its registered office at Vallabh Bhawan, Bhopal, Madhya Pradesh – (hereinafter referred to as "DTESDE"), which expression shall, unless repugnant to the context or meaning thereof, shall include its successors and assigns of the FIRST PART;

AND

National Education Foundation, a non-profit organization, head quartered at 1350 Beverly Road, Suite 219, McLean, VA 22101, Washington DC, USA (hereinafter called as "NEF"), which expression shall, unless repugnant to the context or meaning thereof, shall include its successors and permitted assigns of the SECOND PART

DTESDE and NEF are hereinafter referred to singly as "Party" and jointly as "Parties".

WHEREAS:

DTESDE is a department of the Government of Madhya Pradesh and is committed to fulfil the growing need in India for skilled manpower across sectors and narrow the existing gap between the demand and supply of skills. It develops appropriate models to enhance, support and coordinate private sector initiatives.

NEF is a non-profit organization which is one of the largest in the World engaged in bridging the employability, digital and academic divides by providing high quality affordable 21st century online education with total solution model with blended learning in education and technology and awarding certificate through State University of New York. NEF would be implementing & providing all the grants, recourse and enable certification and assessment, as the partner of State University of New York (SUNY), POTSDAM.


The Parties mutually agree to enter into this MOU to record the terms and understanding between the Parties and the manner in which the Parties wish to combine their efforts and collaborate with each other on the skilling initiative.

NOW, THEREFORE, the Parties hereby record the terms of their understanding as follows:

1. AREAS OF COOPERATION

Based on the preliminary discussions between the Parties, DTESDE agrees to enter into an arrangement with NEF. The areas of collaborations and responsibilities are outlined below. The Parties may add or remove any identified area from the list below, as may be mutually agreed between them, from time to time, by way of prior written acceptance from both the Parties.

NEF shall discharge the below listed activities:-

- (i) To train 360 students (180 boys and 180 girls) as Pilot batch from various degrees, viz, Engineering, Arts, Commerce, Science and Management, commencing from June 2018.
- (ii) The skills module shall comprise minimum 90 hours of training (30 hours online and 60 hours classroom) and shall be covered in not more than 90 days for each batch.
- (iii) NEF shall be solely responsible for Training, Evaluation, Certification(SUNY certified with NSDC (Level 6 or above) &DTESDE co-branded).
- (iv) For women trainees, 100% of the cost shall be borne by NEF. For men trainees, 80% of the total cost shall be borne by NEF and 20% of the cost (i.e. Rs 3,900 + Taxes) shall be paid by the Department (DTESDE). The fee payable by DTESDE shall be paid as per NSQF guidelines - 30% of the amount at the time of enrolment, 50% on the completion of the training programme and 20% on placement of 70% of the trained students.
- (v) NEF shall ensure the placement of at least 70% of the trained students.
- (vi) NEF shall provide Faculty, Training of Trainers (ToT) Program, Training and Assessment.
- (vii) DTESDE shall provide the list of campuses where the training has to be conducted and shall provide the necessary classroom infrastructure for the same.

2. OTHER COVENANTS

- (i) This MOU shall be effective from the Execution Date.
- (ii) Neither Party shall be liable to pay any compensation to the other Party in respect of expiry of term or termination of this MOU.
- (iii) Use of logos: Notwithstanding anything contained in this MOU, any other document or communication, the use of the name, logo and/or official emblem etc. of DTESDE or any scheme implemented by it in any publication, document, paper, website or any other platform or mode is allowed only, after seeking explicit prior permission in writing from DTESDE who is the owner of such logo, emblem etc. Such permission may be given by DTESDE at its sole discretion which may further be subject to any condition that NEF considers appropriate.
- (iv) Representation: Neither Party shall represent the other Party in any manner. This MOU does not give authority to NEF to either represent or exercise opinion or decision, on behalf of DTESDE and vice versa.
- (v) Non-recourse: The Parties are entering into this MOU in good faith and intention. Neither Party will be responsible for any liabilities arising out of death, injury nor any legal action in respect of field staff, trainees or any other persons associated with the operationalization of this MOU. DTESDE agrees and confirms that NEF shall not be liable for any losses, claims, liabilities, damages or costs of any nature whatsoever including any loss in relation to failure of DTESDE to meet the objective envisaged in this MOU. For the purpose of this clause, NEF shall include its employees, trainers, directors, representatives, and agents, associated companies and their employees, trainers, directors, representatives and agents. The Parties agree and confirm that notwithstanding anything contained in this MoU, no provision of this MoU is intended to legally bind either of the Parties. Separate definitive agreement(s) shall be entered into by the Parties in case it is intended to create any legal rights and obligations.
- (vi) Confidentiality: Subject to the exceptions provided in this clause hereinafter, Parties

not disclose to any third Person any Confidential Information with respect to the MOU and programme hereunder.
Exceptions: Party may disclose Confidential Information:

- a) to the extent to which it is required to be disclosed pursuant to Applicable Law;
 - b) to the extent to which it is specifically permitted by the other Party in writing;
 - c) to the extent that the Confidential Information is publicly available (other than as the result of a breach by such Party of its confidentiality obligation under MOU
 - d) to its employees and professional advisors, but only to the extent necessary and subject to such employees and professional advisors accepting an equivalent confidentiality obligation to that set out in this Clause Confidentiality.
- (vii) Amendments: This MOU may only be varied by mutual agreement of the Parties in writing.
- (viii) Disputes: This MOU doesn't create any legal or financial obligations on NEF. Any difference or dispute between the Parties concerning the interpretation and/or implementation and/or application of any of the provisions of this MOU shall be settled amicably through mutual consultation or negotiations between the Parties, without reference to any third Party.
- (ix) Governing law and Jurisdiction: This MOU and any matter relating to this MOU shall be governed by and construed in accordance with the laws of India.
- (x) Counterparts: This MOU may be executed in counterparts, each of which shall be deemed to be the original and all counterparts shall collectively constitute a single instrument.
- (xi) Future Plan: After the successful completion of pilot, NEF may present detailed proposal for skilling 2 lakh youths of Madhya Pradesh up to December 2019. The DTESDE may consider such proposal in the light of success of pilot project.
