**15. Multidisciplinary / interdisciplinary**

Hamidia College envisions transforming into a holistic multidisciplinary institution that caters to the diverse academic and personal development needs of students. The plan entails integrating various disciplines, promoting interdisciplinary collaboration, and fostering a culture of innovation and creativity. Emphasis is placed on offering a comprehensive education that goes beyond traditional boundaries, nurturing critical thinking, creativity, and ethical values. The institution aims to prepare students to excel in a rapidly changing global landscape by providing them with a well-rounded education that encompasses academic excellence, social responsibility, and personal growth. Hamidia College adopts an interdisciplinary approach to education, The institution offers a wide range of programs with interdisciplinary combinations, allowing students to explore diverse fields of study and gain a comprehensive understanding of complex issues. For example, students can pursue combinations such as Psychology with Geography or Drawing and Painting, Economics with Urdu or English literature, or Geography with Sociology. These programs are designed to equip students with versatile skills and knowledge that are relevant in today's interconnected world. Hamidia College offers flexible and innovative curricula designed to provide students with a holistic and multidisciplinary education that prepares them for the challenges of the 21st century. For example, students can customize their academic journey and explore their interests while gaining practical experience. College follows NEP curriculum as per BU syllabus which is a multidisciplinary flexible curriculum that enables students to enter and exit at multiple points during their undergraduate education while maintaining academic rigor. The curriculum is designed to provide students with options and flexibility, allowing them to tailor their education to their individual needs and goals. Additionally, students have the opportunity to re-enter the program at a later stage. In accordance with the syllabus prescribed by the college, topics related to gender, human values, and environmental awareness are integrated into the curriculum. Project work forms an integral component of the syllabus for U.G. and P.G. classes, promoting hands-on learning and practical application of knowledge. To further enhance interdisciplinary research efforts, a Research Committee has been established. To nurture critical thinking and analytical skills among students, workshops on Research Methodology and Intellectual Property Rights (IPR) are planned. Faculty members, actively engaged as members of the Board of Studies (B.O.S.),

have made significant contributions to syllabus design and authored textbooks in line with the principles of the NEP. With a focus on fostering innovation and creativity, each department is tasked with creating an activity calendar. These activities are organized around three central themes: Dhara: Activities related to environmental conservation and sustainability; Dharohar: Events showcasing literary and cultural heritage; Srajan: Initiatives promoting innovation and entrepreneurship. By aligning our efforts with the objectives outlined in the NEP and promoting holistic development through diverse activities, we aim to empower our students to become well-rounded individuals capable of meeting the challenges of the 21st century.

#### **16.Academic bank of credits (ABC):**

The Academic Bank of Credits (ABC) facilitates efficient credit access, aiding students in resuming studies early. Induction programs familiarize students with NEP objectives, including multiple entry and exit options and course combinations. Interactive sessions elucidate available choices, while expert lectures align faculty with NEP's outcome-based and learner-centric pedagogical approaches. Through the Learning Management System, faculty members actively participate in developing their own curricula and pedagogical approaches within the framework that has been approved. To enrich their educational experience, students are encouraged to enroll in and successfully finish courses on online learning environments like Swayam.

Industrial visits provide exposure. Swami Vivekananda Career Guidance Cell hosts specialized training sessions. Skilling courses like Tally are planned. Online tools like LMS for skill enhancement are promoted. E-content

Our University has introduced Skill development courses like Medicinal Plants, Export Import Management, E-Accounting and Taxation with GST, Medical Diagnostics, Digital marketing, Salesmanship, and Environmental Studies for our Under graduate courses. Offline and online courses teach in Indian languages and culture. Workshops, seminars on Indian art and culture, and Spoken Sanskrit classes are conducted. Drawing & Painting Department promotes Indian Art through exhibitions, workshops. Cultural Club fosters awareness of Indian ethos. Hamidia College plans to train faculties for bilingual classroom delivery in English and vernacular languages, aligning with NEP. The curriculum integrates Indian Knowledge System, promoting traditional knowledge through UG programs in Hindi, English, Sanskrit, Urdu, and Arabic at UG level. Co-curricular activities enrich cultural understanding, fostering a holistic educational experience - Hamidia College aligns with NEP to preserve and promote Indian languages, ancient knowledge, arts, culture, and traditions. Efforts include introducing Spoken Sanskrit classes and advancing Indian art through the Drawing & Painting Department. The Cultural Club fosters awareness and pride in Indian culture through regular programs. 'Ek Bharat, Shrestha Bharat' initiatives promote national integration and celebrate India's diversity. To preserve and promote Indian languages, Hamidia College can introduce language courses, including Sanskrit,. Workshops and seminars on ancient traditional knowledge, Indian arts, culture, and traditions can be organized. Additionally, cultural events, exhibitions, and heritage tours can be conducted to raise awareness and appreciation among students.

#### **19.Focus on Outcome based education (OBE):Focus on Outcome based education (OBE):**

Hamidia College aligns with NEP by implementing Outcome Based Education (OBE) in all mainstream programmes. Outcome-based education (OBE) is an approach that defines specific learning



outcomes students should achieve. It aligns instructional methods and assessments to support the attainment of those outcomes. OBE emphasizes the development of practical skills and competencies, and assessments are used to measure students' achievement of the outcomes. It aims to improve education quality by focusing on clear outcomes and preparing students for real-world challenges. Hamidia College has meticulously devised a robust plan to integrate outcome-based education into its pedagogical approach. Learning outcomes are meticulously considered; continuous assessment and exams assess the achievement of course outcomes. In departmental and IQAC meetings, pedagogical guidelines, classroom activities, and assessment methods are extensively deliberated upon, leading to the formulation of actionable plans. Curricula are designed with Programme Outcomes (POs), Programme Specific Outcomes (PSOs), and Course Outcomes (COs), reflecting developmental needs. OBE concepts are communicated to students during induction and in departmental activities, facilitating effective learning.

#### **20.Distance education/online education:**

The college follows the curriculum framework offered by the Barkatullah University which has components of Core, Elective, and Vocational Courses. Several faculty members are involved in the development of e-learning tools, e-content, etc. - Wifi connectivity, projectors, smart classrooms, computer labs and latest software enhance the teaching-learning experience. Project work in PPTs is encouraged. During the COVID-19 pandemic, the college provided Google platforms and govt. email IDs to faculty, enhancing the efficiency and quality of online teaching. The college actively promotes blended learning in adherence to NEP and UGC directives. This approach aims to ensure seamless education delivery and foster inclusivity across socio-economic strata. The integration of face-to-face classroom sessions with online activities has been a primary focus, enhancing accessibility and flexibility for learners. Hamidia excels in blending activities, engaging students effectively. Faculty develop e-content shared via WhatsApp, enabling pre-class access to materials. This fosters peer learning, group discussions, and interactive sessions. Students are urged to enroll in SWAYAM online courses. The institute plans to enhance digital infrastructure with Learning Management Systems (LMS). Online distribution of materials and doubt-solving sessions ensures ongoing support and engagement. Our HEI have not introduced any Distant Education courses, but our students have the liberty to learn and get online degree along with regular degree as per the



UGC new Guidelines.

<p>Ensuring effective curriculum delivery is crucial for achieving excellence in teaching and learning. Given our affiliation with Barkatullah University, Bhopal, the syllabus is crafted by the university itself. ### 6.2.2 - The functioning of the institutional bodies is effective and efficient as visible from policies, administrative setup, appointment and service rules, procedures, etc.

Govt. Hamidia College works under the administrative supervision of the Department of Higher Education, Madhya Pradesh, and the office of Additional Director, Bhopal-Hoshangabad, which lays down the standard operating guidelines. Being the lead college of Bhopal, orders received from the higher level are sent to the government/government aided and private colleges under the

authority. The principal is the Head of the institution, supported by Heads of various departments, including Heads of teaching departments, semester cell, IQAC, sports officer, registrar, and librarians. Academic responsibility is managed by various Departmental Heads and faculties under them. Administrative decisions are taken with the approval of Janbhagidari Committee and Staff Council. For grievance redressal, there are Women Empowerment cells, ST/SC cell, CM helpline managed by the college. Institution has a finance committee, planning board, RUSA and IQAC. Finance is procured and managed under the Heads of RUSA/World Bank schemes, Janbhagidari funds and Consolidated funds. All types of appointments teaching or non-teaching are done by the government.

**Internal Audit-** Our college has an Internal Audit Committee which ensures financial transparency. In issues regarding budget, income and expenditure. This committee keeps a tab on the fee received from students with DFC (Daily fee Collection), Bank statement and cash, book. Discrepancies if found are reported to the Principal and are rectified. The College appoints a qualified Chartered Accountant for internal audit of the College. The C.A. audits the finance related documents, balance, budget, income and expenditure, IT return, Form 16, etc.

**External Audit -** The Accountants General MP (AGMP) Gwalior conducts the audit of our college at a regular interval of 1 to 2 years and examines the entire income and expenditure in both government and non-government sources. The minor errors are removed and the audit report is handed over to the head of the institution. The major errors are reported in writing and the complaints are made as per the government rules. In their subsequent audit the AGMP takes up pending audit objections. Treasury and Accounts, Madhya Pradesh conducts their Annual audit of the budget and its expenditure.
