

Conditions

- 1) The candidate must produce two Certificates of Good Character (in the enclosed form), not more than 3 months old, from two different Gazetted Officers not related to the candidate. The retention in service of the candidate is further subject to his being found suitable for Govt. Service in all respects.
- 2) The candidate should produce the original certificates for verification of the date of birth, Academic Qualifications, claim for SC/ST/OBC/Ex.Ser/PH if any, and claim in respect of age relaxation. One photocopy of each of these certificates duly attested should also be produced.
- 3) The candidate must submit Attestation form (enclosed) duly completed in triplicate and also other forms as may be required.
- 4) The candidate will have to take an oath of allegiance to the constitution of India or if the candidate has conscientious objection to oath taking, make a solemn affirmation in the prescribed form before joining.
- 5) The appointment is purely temporary (subject to confirmation on successful completion of probation period of two years) and is liable for termination on one month's notice or one month's pay in lieu.
